

Policies



1. IN ACCORDANCE WITH PROVINCIAL BY-LAW, SMOKING IS STRICKLY PROHIBITED IN THIS FACILITY.
2. FOR SAFETY REASONS, IT IS RECOMENDED THAT PATRONS REMAIN SEATED WHILE IN THE BLEACHER AREA OF THE RINKS.
3. NO STICKS, PUCKS, BALLS, SKATEBOARDS, ETC. TO BE USED ON THE FLOOR ON THE RINK LEVEL OR IN THE VIEWING AREA ON THE UPPER LEVEL
4. NO CLIMBING ON RINK GLASS.
5. HELMETS ARE TO BE WORN AT ALL TIMES FOR ON ICE ACTIVITIES WHICH INVOLVE HOCKEY STICKS AND PUCKS.
6. PATRONS ARE NOT PERMITTED ON THE ICE WHILE THE ICE IS BEING CLEANED. GATES ARE TO REMAIN CLOSED UNTIL THE ICE MACHINE HAS LEFT THE ICE SURFACE. (EXCEPTION: WHEN MOVING GOAL NETS FOR THE DRIVER)
7. ABUSIVE LANGUAGE/BEHAVIOUR TOWARD OTHER PLAYERS, COACHES, OFFICIALS, PARENTS, SPECTATORS OR EMPLOYEES WILL NOT BE TOLERATED. AFTER ONE WARNING AN INDIVIDUAL WILL BE ESCORTED FROM THE RINK.
8. DAMAGE TO DRESSING ROOMS WILL BE THE RESPONSPONSIBILTY OF THE USER NAME OR GROUP.
9. GARBAGE SHOULD BE PLACED IN THE RECEPTACLES PROVIDED IN THE BLEACHERS AND DRESSING ROOMS. PLEASE KEEP OUR FACILITY CLEAN.
10. VANDALISM TO TWIN RINKS PROPERTY MAY LEAD TO TEMPORARY OR PERMANENT EXPULSION FROM TWIN RINKS. THIS INCLUDES, BUT IS NOT LIMITED TO DRAWING ON WALLS, PUTTING HOLES IN WALLS, BREAKING LIGHTS,ETC.
11. RUNNING IS NOT PERMITTTED IN THIS FACILITY.
12. SKATES ARE NOT PERMITTED ON THE STAIRS OR IN THE MEZZANINE AREA.
13. MANAGEMENT IS NOT RESPONSIBLE FOR LOST OR STOLEN ARTICLES. THE LAST PERSON TO LEAVE THE DRESSING ROOM SHOULD ENSURE THE DOOR IS LOCKED.
14. ANYONE USING THIS FACILITY FOR ANY PURPOSE WHAT SO EVER DOES SO AT THEIR OWN RISK.
